Eighty percent of the chosen students are female because education for girls is key to ending poverty.

## **The Oregon Community Foundation**

The Oregon Community Foundation was established in 1973. Their assets are over \$2.5 billion and they award over \$100 million in grants each year. It is the fifth largest community foundation in the United States.

### **How can this fund last forever?**

As mandated by the US Federal Law that regulates community foundations, no one can terminate the fund.

The staff of the Oregon Community Fund are obligated to follow the specific distribution guidelines established when the fund was created.

If, for any reason, it becomes impossible to support students in Cambodia, then the funds will be used to support equally deserving low-income university students in another impoverished developing country.

## Four Ways You Can Donate to the Education for Low-Income Rural Youth Fund

### 1. Bequest in your will

With the help of an advisor, you can include language in your will, trust, fund, or endowment specifying a gift be made as part of your estate plan.

Here is an example of language to include in your will:

*I give,*

[describe the assets of the bequest; for example: a stated sum, the residue of the estate (the residue is the amount after all other gifts, debts, fees and costs are paid), or a percentage of the residue of the estate]

*to the Education for Low-Income Rural Youth Fund (Fund #492144) of The Oregon Community Foundation ("OCF"), Portland, Oregon, tax ID# 23-7315673, an Oregon non-profit corporation.*

### 2. Make the fund a beneficiary of your IRA and/or other accounts

Making the fund a beneficiary of your IRA, retirement plan, life insurance policy, bank account, CD, or other managed account can be a simple process with the help of your account manager.

You can designate all or a portion of the funds remaining in your account as a gift to this fund.

You can get a beneficiary designation form from your account manager or download it online. If you are married, you will need to complete a spousal waiver form, also available from your account manager.

### 3. You can make a donation to the fund at anytime by check or credit card

### 4. Tax-free IRA charitable rollover

If you are 70½ or older, contact your IRA plan administrator to make a gift from your IRA directly to Friendship with Cambodia (tax ID# 90-0111740) and specify that you wish the donation to go to the Education for Low-Income Rural Youth Fund.

Because the gift goes directly to Friendship with Cambodia without passing through your hands, the dollar amount of the gift may be excluded from your taxable income up to a maximum of \$100,000 annually, with some exceptions.
